# On the state level...

All not-for-profit applicants must now pre-qualify on the NYS Grants Reform Website at grantsreform.ny.gov/grantees in order to apply for certain New York State grant solicitations. Potential not-for-profit applicants are strongly encouraged to begin the process of registering and pre-qualifying immediately as this is a lengthy process.

### NYS Office of Mental Health, Suicide Prevention Programs for Hispanic/ Latino, Black/African American, Asian American/Pacific Islander, American Indian/Alaskan Native and LGBTQI+ New York Youth and Young Adults

In light of the increased number of adolescents and young adults who have reported trying to die by suicide, as well as the unique cultural factors that must be considered in the development of programs and suicide prevention activities, the New York State Office of Mental Health is announcing the availability of funds to nonprofit agencies and tribal organizations serving at-risk youth and/or young adults.

These grants are intended to assist community agencies with the development of innovative programming to provide culturally relevant suicide prevention interventions for Hispanic/ Latino, Black/African American, Asian American/Pacific Islander, American Indian/Alaskan Native and LGBTQI+ youth and young adults. Agencies will be required to partner with an identified behavioral health provider agency to facilitate access to treatment services for individuals who need them.

- Eligibility: Eligible applicants include not-for-profit agencies with 501(c)(3) incorporation located and doing business in New York State and American Indian tribes or tribal organizations located in New York State.
- Deadline: Sep. 8, 2022, 1 p.m. ET
- **Funding:** A minimum of five (5) awards will be made in amounts of up to \$1 million each for a 12-month period.

### On the federal level...

### Department of Health and Human Services, Nurse Education, Practice, Quality and Retention-Registered Nurse Training Program

The Nurse Education, Practice, Quality and Retention (NEPQR) Registered Nurse Training Program (RNTP) aims to enhance nursing education and practice to increase the number of nursing students trained in acute care settings to address and manage social determinants of health factors and improve health equity and health literacy in underserved areas.

The program intends to advance the health of patients, families, and communities and improve health outcomes by strengthening the capacity and skillset of undergraduate student nurses (including underrepresented racial and ethnic minorities) prepared to provide high quality culturally sensitive care in underserved communities.

- **Eligibility:** Eligible entities include accredited schools of nursing, as defined by section 801(2), a health care facility, including federally qualified health centers or nurse-managed health clinics, or a partnership of such a school and facility. Schools of nursing affiliated with the proposed project must be an accredited public or private non-profit school. Applicants must provide documentation of current accreditation by a national nurse education accrediting agency or state approval agency recognized by the U.S. Department of Education for the purposes of nursing education. Individuals and for-profit entities are not eligible to apply. In addition to entities in the 50 states, entities in the District of Columbia, Guam, the Commonwealth of Puerto Rico, the Northern Mariana Islands, American Samoa, the U.S. Virgin Islands, the Federated States of Micronesia, the Republic of the Marshall Islands and the Republic of Palau may apply. Tribes and tribal organizations may apply for these funds, if otherwise eligible. Foreign entities are not eligible for this HRSA award. A trainee receiving support from grant funds under this program must be a citizen, national or permanent resident of the United States. Individuals on temporary or student visas are not eligible to participate.

### Federal Highway Administration, Tribal Transportation Program Safety Fund

Under recently passed infrastructure legislation, 4% of available yearly TTP funds are set aside to address transportation safety issues in Native American communities. Grants are available to federally recognized Indian tribes through a competitive, discretionary program. The program funds projects that address the prevention and reduction of death or serious injuries in transportation-related incidents, such as motor vehicle crashes. Transportation fatalities and injuries disproportionately affect Native American communities and impede their quality of life. The Federal Highway Administration encourages the development of transportation safety plans to assist tribes in determining how to best address transportation safety needs in and around tribal communities. Eligible projects for the TTP Safety Fund include: development and update of transportation safety plans; crash data assessment, improvement, and analysis; systemic roadway departure countermeasures; and infrastructure improvements and other eligible activities.

Eligibility: Eligible applicants for TTPSF discretionary

grants are federally recognized tribes identified on the list of "Indian Entities Recognized and Eligible to Receive Services from the Bureau of Indian Affairs". Other entities may partner with a tribal government to submit an application, but the eligible applicant must be a federally recognized Indian tribe. A tribe may submit more than one application; however, only one project may be included in each application.

- Funding: This grant opportunity is expected to result in the distribution of annual funding ranging from up to \$23.1 million in FY 2022 to up to \$25.1 million in FY 2026.

### On the private level...

### WITH Foundation, Supporting Healthcare Equity for Women with Intellectual and Developmental Disabilities

In an effort to foster health care equity for women with intellectual and developmental disabilities, the WITH Foundation is providing funding to support projects working to that end. The WITH Foundation (WITH) promotes comprehensive health care for adults with intellectual and developmental disabilities(I/DD) in the United States and works to tackle the inadequacies of our health system in addressing fundamental needs of adults with developmental disabilities.

WITH invites collaborative proposals for projects that use one of the following approaches:

- Implementation: Support implementation of models, i.e., projects that support community-based PCPs in providing care to women with I/DD;
- Educational resources: Develop additional educational resources for Primary Care Providers regarding the experiences of women with I/DD; and
- Research: Support regional or national research related to the care that women with I/DD receive from Primary Care Providers.

A secondary goal of this RFP is to foster new partnerships or significantly enhance existing partnerships between disability organizations, advocates, community organizations and health care providers. Projects that intentionally address the experiences of Black women with I/DD, women of color with I/DD and other historically excluded perspectives within inclusive gender-based and gender-affirming care are also encouraged.

- Eligibility: Eligible applicants include tax-exempt nonprofits as defined by section 501(c)(3) of the Internal Revenue Code, including health care, community, and disability organizations based and operating in the United States.
- **Funding:** Grants of up to \$50,000

# The Greenwall Foundation, Faculty Scholars Program

The Greenwall Faculty Scholars Program in Bioethics is a career development award that enables junior faculty members to carry out innovative bioethics research. The program supports research that goes beyond current work in bioethics to help resolve pressing ethical issues in clinical, biomedical and public health decisionmaking, policy and practice. Furthermore, it creates a community that enhances future bioethics research by scholars and alumni/ae. Each year, the foundation selects approximately three Greenwall Faculty Scholars to receive 50% salary support for three years to allow them to carry out a specific research proposal and develop a research program. Scholars and alumni/ae attend twice-yearly meetings, where they present their works in progress, receive feedback and mentoring from the Faculty Scholars Program Committee and other scholars and alumni/ae and have the opportunity to collaborate with other researchers. The ongoing involvement of alumni/ae with the program provides participants with ongoing opportunities for professional development and feedback and allows them to provide critical mentorship for younger scholars.

- Eligibility: Applicants must be junior faculty members at a university or nonprofit research institute that has tax-exempt status in the United States. Applicants must hold a faculty appointment that allows at least 50% of their effort to perform research. Priority will be given to applicants who have not yet been considered for tenure or an equivalent promotion; whose research will have an impact on clinical, biomedical and public health decisionmaking, policy and practice; and who will make important contributions to the field of bioethics over the course of their career.
- Funding: The award supports 50% of a scholar's salary plus benefits for three years up to the NIH salary cap, with 10% institutional costs for salary and benefits. This funding is intended to ensure that at least 50% of the scholar's time is devoted to bioethics research. In addition, the foundation provides \$5,000 each year for limited project support and travel.
