On the State Level

NYS Division of Criminal Justice Services (DCJS), Transformative Youth Justice Hubs

Funding is available to create the first ever Transformative Youth Justice Hubs in New York State. Approximately four Hubs will be funded and designed to support youth justice prevention efforts in rural or urban areas in New York State. Hubs are not intended to provide programs or services, rather, they will develop policies, strategies and solutions that align tools, resources and messages to support youth in reaching their full potential.

NYS Dept. of Health (DOH), Doctors Across New York (DANY)

These grants fund several programs collectively designed to help train and place physicians in a variety of settings and specialties, to provide health care services to New York's under-served, diverse population thereby increasing access to comprehensive, quality care consistent with the DOH's mission to eliminate health disparities and promote health equity in the state. The DANY Physician Loan Repayment (PLR) and Physician Practice Support (PPS) programs make funds available to help recruit physicians to and encourage them to remain in medically underserved areas of the state. Funding is provided in exchange for a physician's commitment to practice medicine in an underserved area for a three-year period (DANY service obligation period).

US National Science Foundation (NSF), Research Traineeship (NRT) Program

This funding will help explore ways for graduate students in research-based master's and doctoral degree programs to develop the skills, knowledge and competencies needed to pursue a range of STEM careers. RedRover Safe Housing Grants for Domestic Violence and Animal Shelters

RedRover's Safe Housing grants help survivors of domestic violence by removing a barrier to safety and allowing pets and people to escape abuse together. Flexibility in how to implement your pet program ensures that there is a solution for every community. Grants of up to \$60,000 are offered to nonprofit domestic violence and animal organizations across the United States. Funding may be used to build or renovate spaces dedicated to housing survivor's pets, begin a foster program to care for survivor's pets, pay for temporary boarding for survivor's pets, or a combination of services that will best serve your community. Grant funds may also be used for routine veterinary care, emergency veterinary care and pet deposits.

CIA Undergraduate Stokes Scholarships

The Undergraduate Scholarship Program is a financial needs-based initiative that offers undergraduate students an unmatched experience. Undergraduate students, serving as scholarship recipients with CIA, attend an accredited college/university on a full-time basis and work during summer breaks at the agency. While working at CIA, you will be exposed to real intelligence challenges while performing meaningful work that relates to your college major.

Deadline: September 1, 2025, 11:59 PM

Eligible Applicants Must:

- be 18 years of age at the time of application submission
- attend school full time
- have a high school diploma, GED, bachelor's degree, or be a current student

Stokes Scholars Must:

- exhibit financial need as demonstrated by the adjusted gross annual household income (AGI) ceiling up to \$120,000; if the scholar has not been listed as a dependent for the previous tax year, the AGI ceiling is up to \$50,000
- accept Stokes scholarship funds and sign a Continued Service Agreement that obligates you to work at the CIA 1.5 years for every year that you are in the Stokes Scholarship Program
- work a full-time schedule (40 hours/week) for a minimum of 12 weeks each summer in the WMA until graduation and onboard as full-time officer (there is no break in service post-graduation; non-local scholars receive relocation entitlements)
- maintain competitive GPA (minimum 3.0 on a 4.0 scale)
- remain in full-time status as a student while in the program (min. 12 credit hours for undergraduate programs)
- continue to major in the degree that aligns with the occupation for which you were admitted into the program
- provide transcripts within 30 days of each semester completion
- maintain a high standard of work performance, attendance and conduct at both school and work
- meet the minimum requirements for joining CIA, including U.S. citizenship and a background investigation

The Gates Scholarships (TGS)

The scholarships are highly selective, last-dollar scholarships for outstanding high school seniors from low-income households. Scholars will receive funding for the full cost of attendance* that is not already covered by other financial aid and the Student Aid Index, as determined by the Free Application for Federal Student Aid (FAFSA), or the methodology used by a scholar's college or university.

*Cost of attendance includes tuition, fees, books, housing and food, and may include additional personal costs.

Deadline: September 15, 2025

Eligible Applicants Must:

- be a high school senior
- be Pell-eligible
- be a US citizen or permanent resident

- be in good academic standing with a minimum cumulative GPA of 3.3 on a 4.0 scale (or equivalent)
- plan to enroll full-time in a four-year degree program, at a US accredited, not-for-profit, private or public college or university

An Ideal Candidate Will Have:

- an outstanding academic record in high school (in the top 10% of his/her graduating class)
- demonstrated leadership ability (e.g., as shown through participation in community service, extracurricular, or other activities)
- exceptional personal success skills (e.g., emotional maturity, motivation, perseverance, etc.)
