SUBJECT: Building code enforcement practices

<u>PURPOSE</u>: To examine the administration and enforcement of the New York State Uniform Fire Prevention and Building Code

The New York State Department of State oversees the administration and enforcement of the New York State Uniform Fire Prevention and Building Code (Uniform Code) by local governments. Under current law, the Department of State also approves code enforcement training programs and minimum qualifications for code enforcement personnel in order to help ensure effective code enforcement practices. This hearing seeks to examine the administration and enforcement practices for the Uniform Code, including the role of the Department of State in the oversight of local government code enforcement activities and requirements for code enforcement officer certification. Input from relevant stakeholders will be valuable to ensure best practices are followed in the interest of protecting the health, safety, and security of all New Yorkers.

Persons wishing to present pertinent testimony to the Committees at the above hearing should complete and return the enclosed reply form as soon as possible. It is important that the reply form be fully completed and returned so that persons may be notified in the event of emergency postponement or cancellation.

Oral testimony will be limited to five minutes' duration. In preparing the order of witnesses, the Committees will attempt to accommodate individual requests to speak at particular times in view of special circumstances. These requests should be made on the attached reply form or communicated to Committee staff as early as possible. Ten copies of any prepared testimony should be submitted at the hearing registration desk. The Committees would appreciate advance receipt of prepared statements.

Attendees and participants at any legislative public hearing should be aware that these proceedings are video recorded. Their likenesses may be included in any video coverage shown on television or the internet.

In order to further publicize these hearings, please inform interested parties and organizations of the Committees' interest in hearing testimony from all sources.
